The scheme of fee support to the IGNOU students belonging to SC/ST categories seeking fresh admissions and re-registration in January 2022 admission cycle is extended with following:

For Fresh SC/ST Students

- For fresh admission of January 2022, the benefits of scheme is extended to academic programmes given in the Annexure-I.
- A registration fee of Rs. 200/- will be charged from SC/ST applicants seeking fresh admission.
- For fresh admission of January 2022, Parents'/Gurdians' income of fresh applicants from all sources should not exceed Rs. 2.5 lakhs during the last financial year as per Government of India Norms. Fresh applicants should submit income certificate issued by the authorized government agency while taking the admission.

For Re-Registering SC/ST Students

- Earlier process of Re-registration is to be maintained for SC/ST students who had already availed the benefits of the scheme in earlier admission cycles with the conditions laid under notification no. 32 dated 26th June, 2021 (enclosed).



NOTIFICATION No 32

With reference to the scheme of fee exemption of IGNOU under SCSP/TSP Grant, the benefits of fee exemption is extended to the students belonging to SC/ST categories seeking fresh admissions and re-registration in July 2021 admission cycle with the following conditions:

- a) The benefits of scheme is extended only in academic programmes given in the Annexure-I.
- b) The scheme is not available for modular certificate/diploma programmes which form part of a degree programme. Beneficiaries, who are enrolling simultaneously in a certificate level programme along with an under-graduate programme shall be eligible for fee exemption only in one programme.
- c) SC/ST applicants who are eligible and willing to avail the benefits of fee exemption shall submit their applications in online mode along with softcopy of documents required for the claim. Applicant should apply with a caste certificate issued by Central/State Government's authorized officer. Student Registration Division will verify the claim certificates in online mode.
- d) Applicant should be eligible as per laid requirements to seek admission in the specific academic programme, including entry qualification, age etc
- e) SC/ST Students who were given exemption/reimbursement of fee during fresh admission shall be eligible for exemption of fee in re-registering in July 2021 cycle.
- f) Applicant should not be employed by any Government/Semi government or Private sector. An undertaking to this effect that the applicant is not employed to be uploaded along with admission application.
- g) Applicant has not taken/ taking any benefit of exemption/reimbursement or not having any Scholarship/funding from any other source/agency during the period of study. An Affidavit to the effect is to be uploaded along with application form.
