NOTIFICATION

The Academic Council's Standing Committee in is 65th meeting held on 17th January, 2025 recommended the mapping of IGNOU Courses of BCOMG / BCOMGOL / BCOMF / BCOMFOL / MCOM / MCOMOL and the courses of Institute of Chartered Accountants of India (ICAI) for credit transfer/exemption, subject to the condition that the same would be in line with the University's Credit Transfer Policy. These recommendations were approved by the Academic Council in its 83rd meeting held on 18th February, 2025.

In view of the above, the transfer of credits and mapping of courses in these programmes is allowed with immediate effect as per the Credit Transfer Policy of the University. The course mapping and guidelines are attached as **Annexure-1**, 2 & 3. A student can claim the credit transfer / exemption against a particular course passed from the Institute of Chartered Accountants of India one time only. The validity of the courses for credit transfer will be 7 years.

There will be no Fee for credit transfer and change of course associated with credit transfer in this case. Only a one-time non-refundable processing fee of Rs. 500/- up to 16 credits and Rs.1000/- for more than 16 credits has to be paid.

This notification is being issued with the approval of the competent authority.

Annexure-3

Rules and Regulation

- The students of Institute of Chartered Accountants of India (ICAI) will be given credit transfer for the course(s)
 they have completed from (ICAI) to the credits of IGNOU programme.
- 2. The student will complete the remaining course from IGNOU.
- The credit transfer shall be considered for the courses which have been completed/studied from ICAI. The credit transfer shall not be considered against the courses exempted by the ICAI.
- To avail the facility of the credit transfer/exemption scheme, the ICAI students have to take fresh admission to respective Programme of IGNOU fulfilling the eligibility criteria for the same.
- The credit transfer so permitted will be spread over a period of minimum duration of the programme specified by IGNOU.
- 6. The minimum and maximum duration of the programme shall be applicable for exercising the provision of Credit Transfer/Exemption. The student shall apply for credit transfer/exemption during the final semester/year or after completion of the minimum period but within the maximum period of the concerned programme. In any case, the degree cannot be awarded before completion of the minimum period of the programme.
- 7. The credit transfer/exemption against a particular course passed from ICAI is permitted one time only.
- 8. No credit transfer fee will be charged in this case.
- 9. The student has to submit an application to the Registrar, Student Registration Division (SRD), IGNOU, Maidan Garhi, New Delhi 110068 along with the Marks Sheet of the courses successfully completed from ICAI as per the course mapping complying the university norms notified from time to time.
